QUÉBEC - INTEGRATED MANAGEMENT OF

**EMERGENCY CALL PROCESSING** 

WHEREAS the handling of primary (911) and secondary (fire) emergency calls for the territory of the Municipality of Bonne Esperance are the subject of two service agreements with the Centre d'appel d'urgence des régions de l'Est du Québec (CAUREQ) for the centralized 911 emergency call service (SCAU) and for the secondary fire emergency call service (SSAU);

WHEREAS these agreements will be automatically renewed on December 1, 2024 and January 1, 2025 respectively;

WHEREAS the current operation of our services allows for the integrated management of emergency calls between the various departments involved;

WHEREAS the adoption of Bill 15, which has a direct impact on the governance of the CAUREQ;

WHEREAS the possibility that CAUREQ 's operations could be affected and the integrated management of emergency call processing compromised.

### ACCORDINGLY,

It is proposed by Mrs. Angela Spingle seconded by Clara Buckle and unanimously resolved by Council

**THAT** the Municipal Council ask the *CAUREQ*, regardless of the mode of governance that will be put in place, to maintain integrated management for the handling of emergency calls from the territory of the Municipality of Bonne Esperance;

**THAT** should this not be the case, the Municipal Council reserves the right to study other options that would make it possible to maintain this standard and, if necessary, to terminate the said agreements in accordance with the provisions set out in Article 10 thereof;

REQUEST FOR COMMUNITY SUPPORT FOR A REGIONAL CONCERTED APPROACH TO THE MINISTÈRE DES AFFAIRES MUNICIPALES ET L'HABITATION (MAMH) TO **PROPOSE** REALISTIC FINANCIAL SOLUTIONS ADAPTED **ISOLATED** COMMUNITIES <u>O</u>F **TERMS ACCESS** TO **MUNICIPAL** INFRASTRUCTURE REQUIRED COMPLIANCE AND LOCAL AND REGIONAL ECONOMIC DEVELOPMENT.

**CONSIDERING THAT** many cities and municipalities in Quebec are faced with the challenge of upgrading their water and wastewater infrastructures, yet lack the financial means to do so;

**CONSIDERING THAT**, despite well-known government programs (e.g. PRIMEAU, TECQ and others) available to towns and municipalities, even access to these funds is often restrictive, as it has a major impact on municipal debt levels and, consequently, on citizens' indebtedness;

**CONSIDERING THAT**, often in these small, isolated municipalities, where the impacts of local devitalization are also evident, not only does access to a government grant lead to excessive municipal indebtedness, but the basic municipal financial portion required to access the grant in question becomes impossible because the annual budget simply does not allow it;

CONSIDERING THAT this situation of documented and urgent local infrastructure needs versus non-availability of the necessary funds exposes municipalities to considerable financial sanctions and penalties, among others with regard to obligations under section 30 of the Act respecting the "Règlement sur les ouvrages municipaux d'assainissement des eaux usées du Ministère de l'environnement et de la lutte contre les changements climatiques (MELCC);

**CONSIDERING THAT,** once again, this situation is a hindrance to local economic development, all the more so for municipalities suffering from devitalization;

WHEREAS, the Municipality of Bonne Esperance has documented and made financial projections of what its current need for a new wastewater infrastructure and associated significant operating costs represent for the Municipality and its citizens;

**CONSIDERING THAT**, without a change in the situation or in the financial tools that could be made available to it, it will be impossible for the Municipality to proceed and comply with the Act and environmental standards.

IT IS **THEREFORE** proposed by Robbie Thomas, seconded by Garland Nadeau and unanimously resolved:

RESOLUTION TO DRAW ATTENTION TO THE IMPACT OF THE CANADA POST STRIKE ON THE MUNICIPALITY OF BONNE ESPERANCE

WHEREAS our municipality depends on Canada Post's delivery service for commercial supplies and online purchases (Christmas);

It was proposed by Angela Spingle, seconded by Clara Buckle and unanimously resolved to draw attention to the impact of the Canada Post strike on the Municipality of Bonne Esperance and to suggest that an alternative be imposed by Canada Post or another government entity, or that the government order the workers back to work.
